### **MINUTES**

President Smith called the meeting to order at p.m. He led those present in the Pledge of Allegiance.

#### **ROLL CALL**

#### **PUBLIC COMMENT**

Secretary Shannon provided an overview for making public comment to the board.

David Logel addressed the board to express his concerns on the Liaison Officer Contract Amendment.

Joel Clark addressed the board regarding ABA Therapy and adding a BCBA position in the district.

Andrea Clark addressed the board sharing her family is working with Representative Dievendorf's office on legislation to address barriers to ABA therapy and requested the district to hire a BCBA.

Leanne Kirmann addressed the board seeking information on who is on the health advisory committee, if there are any cases in the district where a child has been treated without parent consent and is so how many, and how to access policies (school policies) for the new clinic.

#### **DISCUSSION ITEMS**

#### A. 98B Data Presentation

Assistant Superintendent for Academic Services, Dr. Steve Gabriel presented the board with a detailed overview of the district's end of year K-8 Math and ELA Goal Report and the High School Math and ELA Goal Report respectively noting this is the end of year report. He reminded everyone the mid-year report was presented during the February 13, 2023 meeting.

#### **B.** Superintendent Evaluation Update – Community Relations

Superintendent Barnes provided his update with focus on Staff Relations, Section C of the Superintendent's Evaluation Rubric. He provided the established goal and the current initiatives established under reach of the goals including Staff Feedback, Staff Communication, Personnel Matters, Delegation of Duties, Recruitment, Labor Relations (Bargaining), and Visibility in the District.

#### A. APPROVAL OF MAY 22, 2023 MEETING MINUTES

Mr. Shiflett advised the all of the upcoming payment approvals were reviewed by the Board Bond Advisory Committee prior to be brought forward for Board Action, including the purchase of the weight room equipment and the bid award for Wacousta. He noted these invoices represent work for the Delta Center Fire Suppression.

The motion carried unanimously.

Mr. Shiflett noted this represents bond work at Delta Center.

The motion carried unanimously.

Mr. Shiflett noted this represents work at the Beagle pool and track equipment.

The motion carried unanimously.

Mr. Shiflett noted this is for work on the Fine Arts addition.

The motion carried unanimously.

#### **COMMENTS FROM STAFF AND BOARD**

President Smith clarified his comments regarding responding to public comment.

Director of Communications John Ellsworth noted we experienced some technical issues with the recording of tonight's meeting so the view may appear different but ensured the live stream was going out and the video will be posted on the website. He further shared information regarding a \$5,000 donation to the Beagle library through the National Defense Industrial Association noting WILX ran a story covering the donation.

Assistant Superintendent of Academic Services Steve Gabriel commended everyone for the Class of 2023 Commencement Ceremony held at the Breslin Center last Friday expressing it was nice to be back at the Breslin Center.

Human Resources Director Kelly Jones noted it was almost one year ago today that the board accepted her hiring commenting the year has flown by. She expressed her appreciation to Dr. Barnes for taking her under his wing following her hiring in the midst of our former Superintendent's departure and expressing she could not ask for a better person to step into the role of Superintendent noting he is an exceptional leader.

Superintendent Barnes commented the Commencement Ceremony was great and congratulated our student graduates and all of our staff who assisted in getting our students there. He reminded everyone this is the last week of school. He shared that the Health Care Advisory Team, working through a grant and the Eaton RESA includes parents who expressed interest in being a part of the planning process and input is being sought from students as well. He noted Grand Ledge Public Schools is not providing health care, sharing we are looking to secure a partner/provider that will provide health care services that is housed within the walls of Grand Ledge Public Schools.

Ms. Kuykendoll noted Commencement was spectacular and congratulated all the graduates, their family and friends. She noted in conversations regarding school safety it was not an attack against or on anyone and the board is just doing its due diligence and reassuring the board takes school safety seriously.

Mrs. DuFort commented graduation is always a highlight of the year noting she loves to hear the student speakers. She commended the Lacrosse team on a great showing.

Ms. Shannon reminded everyone there is still time to sign up for the final Grand Ledge Education Foundation Josh Spalsbury Memorial 5K Comet Chase this Saturday noting the Foundation will continue on in its fundraising endeavor this is just the last one in Memorial of Josh Spalsbury.

Dr. Glasscoe commented on the graduation ceremony noting she can envision her grandson walking the stage in a couple years. She went on to share she got the chance to see the Dream Depot today during her visit to Wacousta Elementary School. She thanked the Wacousta staff and noted the students were delightful.

President Smith commented graduation is always exciting.

#### Recommendation

I recommend the Grand Ledge Public Schools Board of Education approve the hiring of Eric Leopold as the Principal of Hayes Intermediate School and Kelly Shumway as the Assistant Principal at Beagle Middle School.

#### **Background**

As you know, Hayes Intermediate School Principal, Kelly Smith, has announced her retirement from the District. To this end, we posted her position internally and received several letters of interest. Eric Leopold has been with the district since 2019 serving as the Assistant Principal at Beagle. Eric has proven himself to be a great building leader and I believe he is the best candidate to fill the vacancy created by Kelly's retirement.

With Eric moving into the leadership position at Hayes, that left his current Assistant Principal position open. Again, we posted the position and I am thrilled that we have an internal candidate ready to step in. Following a thorough interview process, current Beagle Middle School Science and STEM teacher, Kelly Shumway rose to the top as the candidate of choice. Kelly has been with the district since 2019 and already holds her School Administrator Certification. Prior to joining Grand Ledge Public Schools Kelly was a long-time teacher with the Lakewood Public Schools. 



#### **REVENUE**

General fund revenues for the 2023-24 year are projected to equal approximately \$72.1 million. The following factors contributed to the revenue projection:

- The District's State revenues will increase by approximately \$2,700,000 during FY 2024 based upon the Governor's proposed \$458 per pupil increase in the foundation allowance.
- Federal revenues will decrease by \$3,000,000 due the use of the majority of our ESSER funds in FY 2023. Many of these one-time funds were utilized to supplant on-going expenditures as the District rebounded from the impact of the pandemic.
- Incoming transfers will decrease in FY 2024 due to the transfer of the GECKO program revenue, and the associated revenues, to Eaton RESA.

#### **EXPENDITURES**

General fund expenditures are projected to remain fairly steady in FY 2024. The following factors contributed to the expenditure projection:

- Employee compensation costs are projected to increase by approximately \$1.5 million due to salary step increases, ORS retirement rate increases and contract settlements.
- New staff positions for FY 2024 include an elementary ASD program special education teacher, a dean/student support position for Beagle Middle School and an additional early childhood special education teacher.
- Additional contracted services for 2023-24 include a school resource officer for Beagle Middle School.

- All buildings and departments made reductions in expenditures based upon their percentage of the total budget. Reductions include employee attrition in teaching, teaching assistant and secretarial staff.
- District programming changes include the elimination of the elementary distance learning program and a reduction in the use of substitute teachers and employee extra duty assignments.

#### **FUND BALANCE**

The original budget adoption for 2023-24 calls for a basically break-even position leaving the District with a projected ending fund balance of \$7,131,000 as of June 30, 2024. This fund balance level represents 9.89% of revenues, the measurement utilized by the Department of Treasury for early warning monitoring, and 9.89% of expenditures, the measurement utilized by Board Governance Policy EL 404.

## FIRST AMENDMENT TO THE AGREEMENT FOR POLICE SERVICES BETWEEN THE CITY OF GRAND LEDGE AND GRAND LEDGE PUBLIC SCHOOLS BOARD OF EDUCATION

THIS FIRST AMENDMENT ("FIRST AMENDMENT") to the initial AGREEMENT dated June 1, 2022 ("AGREEMENT"), is made and entered into as of the 1st day of \_\_\_\_\_\_\_, 2023, by and between, the CITY OF GRAND LEDGE, a Michigan home rule city, whose address is 310 Greenwood Street, Grand Ledge, MI 48837 (hereinafter the "City") and GRAND LEDGE PUBLIC SCHOOLS BOARD OF EDUCATION, a Michigan general powers school district, whose address is 220 Lamson Street, Grand Ledge, MI 48837 (hereinafter, the "School District")(individually a "Party", collectively, the "Parties").

WHEREAS, the Parties entered into the AGREEMENT on June 1, 2022, to provide for the assignment of a Grand Ledge Police Department officer to the School District to improve school safety and the educational climate of the School by assisting in the maintenance of security for school staff, students, facilities, and the community.

WHEREAS, the Parties desire to restate the June 1, 2022 Agreement except where amended herein by this FIRST AMENDMENT

WHEREAS, all provisions of the AGREEMENT, which do not conflict with this FIRST AMENDMENT, shall remain in full force and effect.

NOW THEREFORE it is mutually agreed as follows:

 RECITALS. The foregoing recitals are incorporated in and form a part of this FIRST AMENDMENT.

- 2. Number of School Resource Officers and Location of Services. In addition to the officer assigned to the School District as a School Resource Officer ("SRO") pursuant to the AGREEMENT, the Grand Ledge Police Department will assign one (1) officer to, but not limited to, the School District's Beagle Middle School as an SRO. Further, this FIRST AMENDMENT permits the City's Manager and the School District's Superintendent to determine SROs and their service location assignments to other School District facilities located within the School District, as mutually agreed upon that shall be memorialized in writing ("writing") as authorized by and between the City's Manager, or designee in his/her absence, and the School District's Superintendent, or designee in his/her absence. Any such writing shall be attached to this FIRST AMENDMENT and binding upon Parties.
- **3. Compensation.** The School District shall compensate the City the cost of the second or subsequent SRO as follows:
  - A. The School District shall compensate wages, benefits, and necessary equipment, except as identified in paragraph 4 of this FIRST AMENDMENT, in a fixed amount of \$135,000 for each of the three years of the FIRST AMENDMENT.
  - B. It is understood and agreed that the compensation levels set forth above may be adjusted by the City due to changes in applicable collective bargaining agreements. No adjustment charged to the School District shall exceed a 2.5% total compensation increase, and any adjustment shall be communicated with the School District in writing upon ratification of the collective bargaining agreement.

- C. Notwithstanding paragraph 3, subparagraph A. above, the School District agrees to actively pursue federal and state grants or other funding to compensate the City for the cost of all SROs up to the total cost of said SRO, to include 100% of salary, fringe, training, and equipment for any position not already compensated for at 100%.
- D. The School District shall remit its portion of said payment to the City not later than the 10th day of the month of the invoice period in the amount of the annual cost divided by the three (3) calendar months (i.e., quarterly payments).
- 4. **Police Uniforms, Equipment, Vehicle, Police Training, Insurance.** The City through its Grand Ledge Police Department shall provide the cost of uniforms, police equipment, a vehicle, and police training. Further, all SROs shall be insured through the City's applicable insurance policies.
- 5. **Term.** The term of this FIRST AMENDMENT shall be three (3) years commencing July 1, 2023; however, either party may terminate this FIRST AMENDMENT for any reason by providing written notice of intent to terminate at least one (1) year prior to the anniversary date, i.e., June 1 of any of the three years. The AGREEMENT shall be extended accordingly and run concurrently with the FIRST AMENDMENT.
- 6. **Binding Effect; Authority to Sign.** This FIRST AMENDMENT shall be binding upon the parties and their successors and assigns, and the parties executing this FIRST AMENDMENT certify that they have been and are duly authorized by the respective parties to execute this FIRST AMENDMENT and to bind the parties to the terms hereof.

- 7. **No Defense Nor Indemnification.** Neither party shall defend nor indemnify the other party for acts or omissions under this FIRST AMENDMENT.
- 8. **Venue and Jurisdiction.** Any litigation of this FIRST AMENDMENT shall be heard in the state courts of Eaton County, State of Michigan. Each party shall be responsible for its individual expenses, including actual attorney fees, witness fees, or other costs related to this amendment.
- 9. **MODIFICATIONS OR AMENDMENTS.** No modifications or amendments of this FIRST AMENDMENT shall be valid unless they are in writing and signed by the duly authorized representatives of both parties. This FIRST AMENDMENT shall be deemed to have been made in and shall be construed in accordance with the laws of the State of Michigan.
- 10. **Mutual Draftsmanship.** This FIRST AMENDMENT will be construed for all purposes as having been drafted jointly by the parties hereto.
- 11. **No Waiver of Defenses.** By entering into this FIRST AMENDMENT, neither party is waiving any defenses, including the defense of governmental immunity.
- 12. **No Third-Party Rights.** Nothing in this FIRST AMENDMENT shall provide any rights to any third party who is not a party to this amendment.
- 13. **Counterparts.** This FIRST AMENDMENT may be executed in any number of counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same amendment.

#### **WHEREAS:**

- 1. By resolution adopted on April 24, 2023 (the "Bond Resolution"), this Board authorized the issuance of not to exceed Forty-Nine Million Four Hundred Twenty-Five Thousand Dollars (\$49,425,000) 2023 School Building and Site Bonds, Series III (the "Bonds"); and
- 2. Pursuant to the Bond Resolution, the Issuer delegated authority to the Superintendent of Schools and/or the Chief Financial Officer (each an "Authorized Officer") to accept a bid on behalf of this Board for the sale of the Bonds within the parameters established in the Bond Resolution; and
- 3. On June 1, 2023, the Issuer received seven (7) bids for the purchase of the Bonds, which were presented to an Authorized Officer for consideration; and
- 4. Based upon the written recommendation of the Issuer's financial consulting firm, an Authorized Officer accepted the offer of KeyBanc Capital Markets Inc., Denver, Colorado (the "Purchaser"), to purchase the Bonds pursuant to the authority delegated in the Bond Resolution, and the Board desires to ratify and affirm the acceptance of the offer.

#### NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Authorized Officer's acceptance of the offer of the Purchaser as set forth in its bid, and the terms and conditions set forth therein, presented to the Authorized Officer on June 1, 2023, to purchase the Bonds at a purchase price of \$24,714,204.00, which is the par value of the Bonds, plus a net original issue premium of \$1,656,744.00, less the Underwriter's discount of \$162,540.00 is hereby ratified and affirmed. The Bonds shall be issued in the mutually adjusted aggregate principal amount of \$23,220,000 and designated 2023 School Building and Site Bonds, Series III (General Obligation - Unlimited Tax). Because the Bonds are being issued at a premium and a portion of such premium is being deposited into the 2023 Capital Projects Fund, the Board hereby acknowledges that only \$24,713,971.13 of voter authorization remains for any future bond issuance.

- 2. The Bonds shall be dated June 29, 2023, and shall mature on November 1 and/or May 1 of the years 2024 through 2042, inclusive, and 2046, on which interest is payable commencing November 1, 2023 and semi-annually thereafter on May 1 and November 1, at the rates and in the principal amounts set forth in Exhibit A and shall be subject to optional and mandatory redemption as set forth herein.
- 3. The Bonds or portions of Bonds in multiples of \$5,000, maturing on or after November 1, 2033, shall be subject to redemption prior to maturity, at the option of the Issuer in such order as the Issuer may determine and by lot within any maturity, on any date occurring on or after May 1, 2033, at par plus accrued interest to the redemption date.
- 4. The Bonds due November 1, 2046, are term bonds subject to mandatory redemption in part, by lot, on the redemption dates and in the principal amounts set forth below and at a redemption price equal to the principal amount thereof, without premium, together with interest thereon to the redemption date, as set forth below.

When term bonds are purchased by the Issuer and delivered to the Paying Agent for cancellation or are redeemed in a manner other than by mandatory redemption, the principal amount of the term bonds affected shall be reduced by the principal amount of the Bonds so redeemed or purchased in the order determined by the Issuer.

5. Notice of redemption of any Bond shall be given not less than thirty (30) days and not more than sixty (60) days prior to the date fixed for redemption by mail to the registered owner's or owners' registered address shown on the registration books kept by the Paying Agent (the "Paying Agent"). The Bonds shall be called for redemption in multiples of \$5,000, and Bonds of denominations of more than \$5,000 shall be treated as representing the number of Bonds obtained by dividing the denomination of the Bond by \$5,000, and such Bonds may be redeemed in part. The notice of redemption for Bonds redeemed in part shall state that upon surrender of the Bond to be redeemed a new Bond or Bonds in an aggregate principal amount equal to the unredeemed portion of the Bond surrendered shall be issued to the registered owner thereof.

If less than all of the Bonds of any maturity shall be called for redemption, unless otherwise provided, the particular Bonds or portions of Bonds to be redeemed shall be selected by the Paying Agent, in such manner as the Paying Agent in its discretion may deem proper, in the principal amounts designated by the Issuer. Any Bonds selected for redemption which are deemed to be paid in accordance with the provisions of the Bond Resolution and this resolution will cease to bear interest on the date fixed for redemption. Upon presentation and surrender of such Bonds at the corporate trust office of the Paying Agent, such Bonds shall be paid and redeemed.

6. Blank Bonds with the manual or facsimile signatures of the President and Secretary affixed thereto, shall, at the direction of bond counsel and as necessary, be delivered to the Paying Agent for safekeeping to be used for registration and transfer of ownership.

The Bonds shall be registered as to principal and interest in the name of the Purchaser and are transferable as provided in the Bond Resolution only upon the books of the Issuer kept for that purpose by the Paying Agent, by the registered owner thereof in person or by an agent of the owner duly authorized in writing, upon the surrender of the Bond together with a written instrument of transfer satisfactory to the Paying Agent duly executed by the registered owner or agent thereof and thereupon a new Bond or Bonds in the same aggregate principal amount and of the same maturity shall be issued to the transferee in exchange therefor as provided in the Bond Resolution, and upon payment of the charges, if any, therein provided. The Bonds are issuable in denominations of \$5,000, or any integral multiple thereof, not exceeding the aggregate principal amount for each maturity.

- 7. Upon delivery of the Bonds, the accrued interest, if any, shall be deposited in the Debt Retirement Fund for the Bonds and the balance of the Bond proceeds shall be used as follows:
- A. The approximate sum of \$133,857.74 shall be used to pay the cost of issuance of the Bonds, and any balance remaining from that sum after paying the cost of issuance shall be deposited in the 2023 Capital Projects Fund.
  - B. The sum of \$24,580,346.26 shall be deposited to the 2023 Capital Projects Fund.
- 8. The Issuer hereby appoints The Huntington National Bank, Grand Rapids, Michigan, as Paying Agent-Bond Registrar and directs an Authorized Officer to execute for and on behalf of the Issuer a Paying Agent-Bond Registrar Agreement.

- Pilot teams convene to discuss process and view rubrics and review process
- Teams meet to review process and rubrics
- Teams meet to review tools and make pilot selections

- Teachers continue training and support sessions
- Pilot teams convene to assess tools using the rubrics and make recommendations

## Recommendations for Board Approval

- 1. Adopt Amplify Science (McGraw Hill) for K 4
- 2. Adopt MyWorld Social Studies (Saavas) for Grade 3

The costs of these programs are built into the academic services budget for the 2023-2024 school year.

## **Next Steps**

If the board approves to adopt MyWorld Social Studies (grade 3), and Amplify Science (K-4), we will:

- 1. work with the vendors to get materials to teachers before the the school year begins
- 2. set up training throughout the summer and into the fall.

We also recognize there are additional curricular needs in the district. Therefore, we will:

1. work with vendors to set up additional pilots in social studies, as well as look ahead to additional potential social studies pilots at the secondary level.
