# GRAND LEDGE PUBLIC SCHOOLS Board of Education

Regular Meeting – June 27, 2016

## **MINUTES**

President Wacyk called the meeting to order at 6:00 p.m. She led those present in the Pledge of Allegiance.

#### **ROLL CALL**

## **OPEN – Truth in Taxation / Truth in Budgeting Hearing**

Motion by Mrs. Winstanley, seconded by Mr. Bennett for the Grand Ledge Public Schools Board of Education to Open the Truth in Taxation / Truth in Budgeting Hearing at 6:02 pm.

## The motion carried unanimously.

Chief Financial Officer Nancy Rasinske provided the board with a details on the district's taxation process including an overview of how millage rates work, the district's tax collection schedule, rules governing fund accounting, general fund millage rates, details of the debt fund noting the millage rate is a constant, but the revenue is variable. She further reviewed the district's Capital Improvement Fund details and changes for the district's property tax rates noting Non-Homestead and Capital Improvement tax rates will not change, but the Debt Service will decrease by .50 mills. She provided details of the final 2015-2016 budget noting a projected fund balance of 7.8% and providing them information on the per pupil foundation allowance noting the district is anticipating a foundation grant increase of \$120 per pupil, which now puts Grand Ledge Public Schools back to where we were in 2010. She reviewed enrollment projections noting the district is planning for enrollment stability for the 2016-2017 school year and reviewed the revenue projections for the year including the foundation grant increase, the Michigan Public School Employees Retirement System costs and the loss of Federal Funding from grants. She reviewed the projected 2016-2017 expenditures and in closing providing an overview of the 2016-2017 general fund budget summary noting a projected ending fund balance, at this time, of 7.83% for the 2016-2017 school year.

In closing, she reviewed the district's cash flow projection noting that under the State's payment schedule the district, like many district's throughout Michigan, will once again be forced to borrow funds through the Michigan Municipal Bond Authority to maintain its fiscal integrity. She noted this year the district will borrow \$3,000,000 (three million dollars) to sustain itself until the State's first state aid payment in October.

Motion by Mr. Bennett, seconded by Mrs. Winstanley to Close the Truth in Taxation / Truth in Budgeting Hearing at 6:23 pm. The motion carried unanimously.

New Willow Ridge Principal Jim Gee thanked the board for the opportunity to lead Willow Ridge and noting he is excited to enter this new chapter in his career. Ms. Weber thanked the board for her appointment to PAC Representative for the district expressing she looks forward to

### **REPORTS**

## A. PRESIDENT'S REPORT

a. **Capitol Connections Report** - Mr. Bennett reported an education bill was passed that included \$40M in funding for MSTEP, even though the house voted to eliminate MSTEP. In addition, the bill contains \$2.5M in funding for private schools for state mandates. He advised MASA, MSBO and MASB are already starting to look into the legal ramifications of this legislation with regard to public education funding being earmarked to private schools.

A discussion among the members centered around this being a step toward voucher implementation.

Mr. Bennett concluded advising the Michigan Department of Education is looking for volunteers to participate in work groups that will develop the implementation process for the ESS Act. If anyone is interested, all information can be found on the MDE website.

- b. **Grand Ledge Education Foundation Report -** Mr. Bennett advised the Josh Spalsbury 5K Comet Chase took place on June 18. He noted sponsorship was up, as were the number of races, however, he does not have final numbers for the event.
- c. **Grand Ledge Parks & Recreation Report** Mr. Boucher reported a summer programming pamphlet has been distributed throughout the community as has been well received. He noted the committee is waiting for the survey report with regard to its Strategic Plan. In closing he advised the construction phase of the board launch has been delayed until August.
- **B.** Superintendent's Report Superintendent Metcalf
  - a. **Elementary A-B-C Report** Elementary Building Principals David Averill, Dawn Kennaugh and Lori Bucholz provided the board with an overview of the Absence, Behavior and Course Completion results for the 2<sup>nd</sup> and 3<sup>rd</sup> Trimester for Neff Kindergarten Center, Beagle Elementary and Delta Center Elementary. Information for Wacousta and Willow Ridge Elementary Schools was also shared with the members.
  - b. **Special Education Monitoring CIMS Report –** Dr. Schutzki advised the board the state requires the district conduct timely IEP's for all students receiving services. IN accordance with state standards and federal rules, an IEP must be reviewed and renewed prior to 365 days of the last IEP. 1005 compliance is mandatory. Dr. Schutzki advised Grand Ledge Public Schools conducted 1,100 IEP's this year. However, seven (7) of those IEP's were conducted late. She advised she has implemented a schedule that will have IEP's conducted a minimum one (1) month before the due date. For teachers who are consistently late on holding IEP's, progressive discipline has been implemented.

#### **PUBLIC COMMENT ON NON-AGENDA ITEMS**

District employee Kimberly Shoup addressed the board stating being a teacher is one of the most important jobs in Grand Ledge and encouraging the board to look into a more appropriate curriculum for social / emotional support of students. She expressed she believes social skills should be taught throughout the year in Kindergarten. In closing, she also expressed her support of having teaching assistants in every classroom K-2.

President Wacyk explained the district's need to borrow money to sustain itself until the state sends its first state aid payment in October. She noted the district has, in past years, borrowed upward of \$6M. While working with the district's legal counsel and looking at the cash flow, it was determined this lesser amount will sustain the district but it is important for constituents to understand there should not be a need for district's to borrow money due to the state's payment cycle.
