Place: Grand Ledge High School – Teacher Parking Lot (West side of building)
Outdoors, under a tent canopy, in compliance with Executive Order 2020-160, which permits outdoor gatherings of up to 100 people.

The meeting will be open to the first 80 in-person attendees. Admission will be on a first-come, first-served basis. Each attendee is required to wear a face covering over his or her nose and mouth for the duration of the meeting. Attendees not from the same household must maintain six feet of distance from one another at all times. Any attendee who does not comply with these rules or the requirements of any current, applicable Executive Order will be required to leave immediately.

The meeting will also be broadcast via Zoom, in accordance with Executive Order 2020-154, for those individuals who cannot attend in person, or who cannot comply with the safety requirements outlined above or contained in any current, applicable Executive Order.
