The General Fund (Operating Fund)



Grand Ledge Public Schools 2019-2020 General Fund Millage Rates

- ☐ Non-Homestead Tax Rates = 18 mills
- ☐ Industrial Personal Property = 0 mills
- ☐ Commercial Personal Property = 6 mills
- \Box State Education Tax = 6 mills



Grand Ledge Public Schools Tax Collection Schedule

Tax Levy	Delta Twp & City of Grand Ledge	All Others
General Fund (Non-Principal Residence only)	100% Summer	100% Winter
Debt & Sinking Fund (all property)	50% Summer 50% Winter	100% Winter



Funding Accounting Rules

General (Operating) Fund

- Source: Foundation Grant (Non-PRE property taxes & state aid), grants
- Uses: Day-to-day operations
- Restrictions: None on Foundation Grant, grants restricted to purpose

Debt Fund

- Source: Tax on all property
- Uses: Bond proceeds used for building, land, buses, technology. Taxes used to make principal and interest payments on voted debt
- Restrictions: Cannot be used for day-to-day operations (Section 1351a)

Capital Improvement (Sinking) Fund

- Source: Tax on all property
- Uses: Building renovation and land acquisition
- Restrictions: Uses controlled by Department of Treasury. Cannot be used for buses, technology,
 or day-to-day operations




Debt Fund Details


- □ Total outstanding debt: \$88.5 million
- \Box Total "Taxable Value" of District = \$1.53 billion
- \Box Principal/interest annual payments = \$8.43 million
- Millage rate calculated for bond payments = 5.63 mills

- 2019 Levy .7968 (Headlee Reduction)
- ☐ Expires 12/21


Per Pupil Foundation Grant — PROJECTED

 - Grand Ledge posted a "limited" number for school of choice students for the 2019-2020 school year.
