

**LETTER OF AGREEMENT #13
BETWEEN
GRAND LEDGE PUBLIC SCHOOLS
AND
EATON COUNTY EDUCATION ASSOCIATION/
GRAND LEDGE EDUCATION ASSOCIATION, MEA/NEA**

Re: Schedule B

1. This Letter of Agreement is developed, approved and executed between the Grand Ledge Public Schools Board of Education (the "District") and the Eaton County Education Association/Grand Ledge Education Association, MEA/NEA (the "Association").
2. The conditions and modifications established through this Letter of Agreement shall be effective for the duration of the 2024 - 2028 Master Agreement.
3. Modify Section 5.4: Schedule B, to include an additional note that says: "Coach salaries, and number of assistants apply to boys and girls sports, where applicable, and boys and girls sports are considered separate seasons and duties."
4. Modify Section 5.4: Schedule B to **eliminate** the following sections:

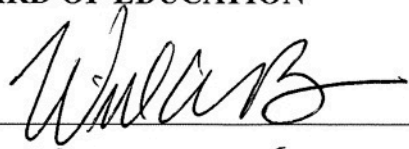
Unified/Special Olympics Coordinator	\$500 per level (1 Elementary, 1 Intermediate, 1 MS, 1 HS)	Paid upon completion of work and processing of submitted paperwork.
Unified/Special Olympics Coach	\$500 per season as outlined by Unified / Special Olympics / MHSAA	Paid upon completion of work and processing of submitted paperwork

5. Modify Section 5.4: Schedule B to add the following sections:

Unified Coach (PreK-8) Coach/coordinate outside of school day sporting events a minimum of 3 outside of school day events per year.	\$500	Paid upon completion of all events
Unified Coach (9-12) will have a minimum of 9 outside of school day events per year.	\$1500	Paid upon completion of all events

Unified Club Coordinator (PreK-4) Will hold 3 (three) events, 1–School-Wide and 2 Wild Card events of the Advisors choosing.	\$600	Paid in teachers’ regular paychecks for the duration of their pay cycles (20 or 24 pays)
Unified Club Coordinator (5-8) Will hold 4 (four) events, 1–School-Wide, 2 Special Olympics and 1 Wild Card event of the Advisors choosing	\$1050	Paid in teachers’ regular paychecks for the duration of their pay cycles (20 or 24 pays)
Unified Club Coordinator (9-12) Will attend 6 (six) events, 1–School-Wide, 4 Special Olympics and 1 Wild Card event of the Advisors choosing	\$2100	Paid in teachers’ regular paychecks for the duration of their pay cycles (20 or 24 pays)
Debate/Forensics Advisor Spring and Fall Competitions	\$2100	Paid upon completion of work and processing of submitted paperwork.
